Open Show: The Northern California Siberian Husky Club will be holding the first Open Show on July 8, 2012.

What is an Open Show?

Although similar to a Sanctioned Match, an AKC Open Show is NOT a Match. It is a brand new titling event. An Open Show is designed for owner-handlers and their dogs to get experience in showing at AKC events. This is the perfect venue for a puppy or dog and owner who is new to showing, or an experienced owner-handler to practice in a more casual, yet official AKC event. As the result of wins at Open Show (and in the 4-6 Month Puppy Competition at AKC Shows), a dog will be awarded points toward the Certificate of Merit (CM) suffix title -- a beginning conformation title. And, to help make this day even more fun for all, the Club is in the process of planning some additional activities, including providing the opportunity for entrants to try out other AKC events!
