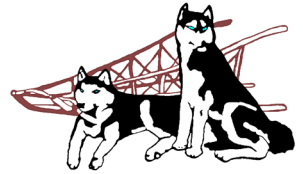

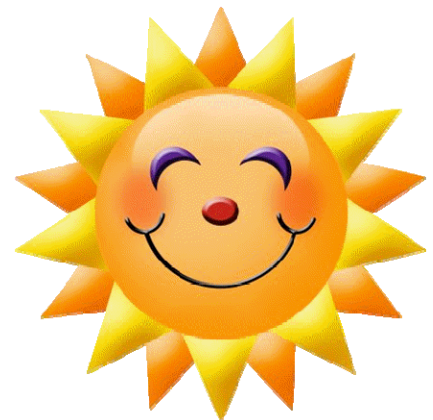
The general meeting will be held 1/2 hour after Siberian judging concludes with the board meeting to follow.
