RECIPE CORNER:

Peanut Butter Dog Treats

2 cups flour
1/2 cup peanut butter
2 eggs
1/4 cup water

You can use other kinds of peanut butter such as chunky, but if you do you'll probably need to add more water to the mixture in order to make it into workable dough.


Preheat your oven to 350 F.

Mix together flour, peanut butter & eggs in a large bowl until slightly combined.


Add in a little bit of water (approximately one Tbsp at a time) until the mixture becomes wet enough to roll out.


Roll out your dough @ 1/4-inch thick & cut into your favorite shapes with some cookie cutters. Bake until golden brown, 12-15 minutes.
