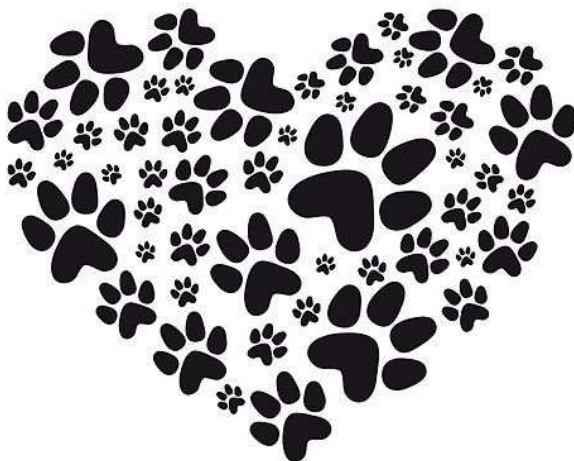
- HAPPY NEW YEAR -
