RECIPE CORNER:

Ring Bait

1 pound liver
½ tsp. Salt
1 cup of corn meal
1 cup of wheat flour
1-2 teaspoon garlic powder

Preheat the oven to 350. In a food processor, using the sharp blade, puree the liver with the garlic powder and salt, if using salt. Add the dry ingredients a bit at a time, blending after each addition. You will have a very stiff mixture. Press it into an oiled cookie sheet or oblong baking pan and press it out as thin as you can. Bake for 20 minutes.


Cool and cut into squares. Refrigerate or freeze.


Here's the extra step that makes this a nice bait to put directly into your pockets: instead of cutting the finished product into squares, cut them into long, thin strips (like biscotti) and then put them back into the turned-off oven to dry. After an hour or so in the oven, then cut the strips into small squares. This gives a drier texture but is still chewy enough to make the dogs happy without grossing out the dry cleaner!

Use at once or freeze until needed...and happy baiting!
