## RECIPE CORNER:

3 Ingredient Dog Treats

1/2 cup sliced apples 1/2 cup peanut butter Directions

Use an apple slicer or a sharp knife to slice up your fruit. If you don't have apples, you can substitute another

fruit or veggie like pears, peaches or carrots.

Add the apple slices and two tablespoons of water to a small saucepan with a lid. Cook over low-medium heat for 10-15 minutes, or until apples are soft enough to mash with a fork.

In a large bowl, mix the 3 ingredients together until they're well-combined. The mix should be thick and a little sticky.

Roll a small amount of the oat mix between your palms to make a "meatball." The size depends on the size of your dog. For larger pups, use 1/2 or 1 tablespoon of mix per meatball. For smaller dogs, use 1 teaspoon. Place treats on a parchment lined baking sheet and bake at 350°F for 15 minutes, until firm. Cool and serve.
